GENERAL NOTES:

- If Customer Purchases an Ambu SmartMan **Site License** Version (+ **Additional SmartMan** Manikins w/TIK), they must be Invoiced as single Customer, at same Site (Location) to receive multiple site licenses. Cannot buy just SmartMan Site License + Additional SmartMan, then relocate Manikins.
- If User Upgrades between SmartMan SKUs in Year 1, Ambu will Invoice Customer Difference in SKU Price Only.
- If User Upgrades between SKUs in Year 2, Ambu to Invoice Full Cost of New SKU (Customer gets 2nd SmartMan & TIK regardless).
- The above pricing and available SKUs are subject to change.

NOTES FOR ANNUAL RENEWAL FEE:

- The Annual Renewal fee is charged for each ongoing year, commencing 12 months from date of software registration.
- The fee is on a per manikin basis unless a site license is purchased. The site license applies to manikins registered to a specific single site.
- It provides ongoing access to the specific number of users purchased.
- It also includes continued access to all software upgrades.
- It includes archiving of test results if client chooses to use the internet option and submits results.
- It provides access to the Admin Page via a web page with password protection.
